Protecting your private information is our priority. This Statement of Privacy applies to the Colorado Energy Foundation's Colorado Disproportionate Impact (CODI) Indicator web application and governs data collection and usage. The Colorado Energy Foundation's website contains the CODI Indicator, an interactive website that provides data and information related to disproportionate impact in Colorado communities. By using the Colorado Energy Foundation website, you consent to the data practices described in this statement.

Collection of your Personal Information

Colorado Energy Foundation may collect personally identifiable information, such as your name, organization and email address. The Colorado Energy Foundation may also collect anonymous demographic information, which is not unique to you, such as your age, gender, household income, political affiliation, race and religion. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Colorado Energy Foundation. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Colorado Energy Foundation website.

Colorado Energy Foundation encourages you to review the privacy statements of websites you choose to link to or from Colorado Energy Foundation so that you can understand how those websites collect, use and share your information. Colorado Energy Foundation is not responsible for the privacy statements or other content on websites outside of the Colorado Energy Foundation website and you use or access these websites at your own risk.

Use of your Personal Information

Colorado Energy Foundation collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Colorado Energy Foundation may also use your personally identifiable information to inform you of other products or services available from Colorado Energy Foundation and its affiliates. Colorado Energy Foundation may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Colorado Energy Foundation does not sell, rent or lease its customer lists to third parties.

Colorado Energy Foundation may share data with trusted partners to help perform statistical analysis or provide customer support.

Colorado Energy Foundation may keep track of the websites and pages our users visit within Colorado Energy Foundation, in order to determine what Colorado Energy Foundation information is the most popular. This data is used to deliver customized content and information to users whose behavior indicates that they are interested in a particular subject area.

Colorado Energy Foundation will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the requirements of the law or comply with legal process served on Colorado Energy Foundation or the site; (b) protect and defend the rights or property of Colorado Energy Foundation; and, (c) act under exigent circumstances to protect the personal safety of users of Colorado Energy Foundation, or the public.

Use of Cookies

The Colorado Energy Foundation website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
